

The meeting was called to order at 3:03 p.m. with the following members and staff present:

Mr. Greg Fountain opened the meeting by asking the Board to review the minutes from the December 14, 2010, meeting. Ms. Lisa Epstein made a motion to approve the minutes as submitted. Mr. Gaius Bruce seconded the motion and the Board unanimously approved.

Mr. Fountain introduced the case, 2011-NAARB-001, "Sakura Sushi & Hibachi" located within the Heart of Navarre overlay district at 8209 Navarre Parkway. Ms. Brenda Shutt, Sign Scene, introduced herself, stated that pictures of the sign in question were provided.

Ms. Epstein then asked if there were requirements for the raceways to match the building. Ms. Stalter stated that there are not; the Board has discretion in that matter. Ms. Shutt stated that raceways typically match the building façade color. The Board then discussed.

Mr. Fountain introduced the second case, 2011-NAARB-002, Tammy Harper and Carla Peterson's residential construction project located within the Town Center Outer zoning district at 851 Laredo Street. Ms. Tammy Harper presented the project which consists of choosing the paint color from the following Sherwin Williams colors: "Latte" (SW 6108), "Hopsack" (SW6109), "Steady Brown" (SW 6110), or "Coconut Husk" (SW 6111); (2) the exterior doors on the pool house must include inserts to give the appearance of French doors.

The Board then discussed other business including the signs at the Mexican grocery store on Navarre Parkway and "Dwon's" as well as "Higher Ground Coffee & Gifts". The Board also discussed the road from Duke Field to Highway 87 South. Staff advised the Board.

Mr. Walters asked for a motion to adjourn. Ms. Martin made a motion to adjourn. Mr. Bruce seconded the motion and the Board unanimously approved the motion. The meeting adjourned at 3:53 p.m.
